FUND DESCRIPTION/OBJECTIVE

The Distillate U.S. Fundamental Stability & Value ETF holds approximately 100 large-capitalization U.S.-listed stocks, systematically selected using the firm's proprietary measures of quality and free cash flow based valuation. The fund seeks to generate long-term excess returns by avoiding stocks of companies that possess high levels of financial indebtedness, and owning those stocks that exhibit a high degree of fundamental stability and the most attractive valuations based on normalized free cash flow.



Fundamental Stability (or Stable Cash Flow) refers to the long-term variability in a company's operating cash flow, with low variability deemed attractive. DSTL is distributed by Quasar Distributors, LLC. The S&P 500 Index tracks the performance of roughly 500 of the largest U.S. stocks. Active Share is a measure of how different a portfolio's holdings are from the constituents of the S&P 500 index, with 100% meaning no overlap between the two.
